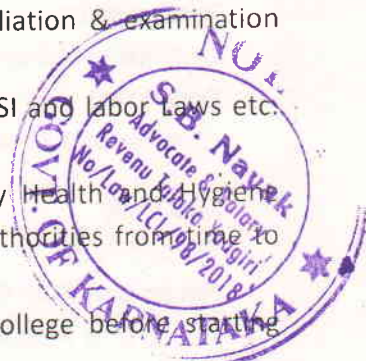

 4. That no part of income from the institution is being and will be diverted to any individual in the society college management committee or to any other person/entity. The saving, if any, after meeting the recurring and non recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the school and extending the cause of education in the same college only.
 5. That College is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institutions, organization or body.
 6. That the College will not open classes under NCTE pattern particularly B.Ed College and will not use college name in any manner without obtaining affiliation from the Gulbarga University, Kalaburagi.
 7. That the Principal and correspondent of the college have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time. The college under takes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.
 8. That the college will ensure compliance of all statutory requirements like EPF, ESI and labor Laws etc. with respect to the college and staff of the college.
 9. That the college will ensure that the Building safety, Fire safety, Water safety Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
 10. That the college will ensure that all required infrastructure is available with college before starting classes.
