- 6. That the College will not open classes under NCTE pattern particularly B.Ed College and will not use college name in any manner without obtaining affiliation from the Gulbarga University, Kalaburagi.
- 7. That the Principal and correspondent of the college have individually gone through the provisions contained in the affiliation & examination byelaws and the circulars issued by the board from time to time.
